**STEP 1**

Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.

**STEP 2**

Refer to PIC 1. Remove the stock mirror by removing the acorn nut and washer(s). Save the washer(s) and acorn nut, they will be reused. Note the order they were disassembled.

**STEP 3**

Refer to PIC 2. Install the mirror stem extenders in place where the stock mirrors were removed. Secure loosely with the washer(s) and acorn nut.

*Note: Add a small amount of blue thread-lock to the threaded stud before installing the acorn nut.*

**STEP 4**

Refer to PIC 3. Thread the long jam nuts on to the stock mirror stem. The cupped end of the long jam nut should go on first with the hex end being closest to the end of the stem.

- STEP 5** Refer to PIC 4. Thread the stock mirror with long jam nut installed in to the mirror stem extender installed in Step 3.

*Note: Add a small amount of blue thread-lock to the threaded mirror stem before installing on the mirror stem extender.*

- STEP 6** Refer to PIC 4. Position the mirror as desired and tighten the long jam nut against the mirror stem extender.

- STEP 7** Tighten the acorn nut to secure the entire assembly to the controls.

- STEP 8** Repeat all steps for the opposite side.
