- M6 x 1 x 40mm Threaded Rod

- M6 x 1mm x 12mm Hex Head Bolt
- M4 x 0.7mm x 10mm Button Head Cap Screws
- M6 Flat Washer
- M6 Lock Nut

Socket and socket bit set, ratchet, Philips screwdriver, flat edge tool



- STEP 1 Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.
- STEP 2 Remove existing license plate and license plate backer, if applicable. Set hardware and parts aside, they will be reused.
- STEP 3 Refer to PIC 2 and 3. Unfasten, disconnect, and remove the existing taillight from the rear fender. Disconnect the rear lights' harnesses from the circuit board located on the taillight's backer plate. Unfasten the taillight's backer plate from the rear fender. Remove metal clip from mounting tab on the rear fender, if applicable. Set all hardware aside, it will not be reused.
- Look for the OEM part number on the back of the taillight's STEP 4 backer plate. The backer plate number should be one of the two following numbers.

HARLEY DAVIDSON 68066-99A **HARLEY DAVIDSON 73381-12**



- STEP 5 Refer to PIC 4 and 5. Using a flat edge tool, gently remove the circuit board from the backer plate. Set backer plate aside, it will not be reused.
- STEP 6 Refer to PIC 6 and 7. Locate provided gasket. Align and place it over the opening in the rear fender. Pull the rear wiring harnesses through the gasket.

HD PART 68066-99A INSTALLATION

- STEP 7 Refer to PIC 8 and 9. Locate provided taillight and the OEM circuit board that was removed in Step 5. Align the bosses located on the back of circuit board with the notches on the backside of the taillight. Connect the light to the circuit board.
- STEP 8 Refer to PIC 10. Locate provided backer plate and two (2) socket head cap screws. Align the backer plate with the backside of the light, and fasten it in place using the provided hardware. Be sure that wires are secured away from any moving parts, excessive heat or pinch points. Fully tighten hardware.
- STEP 9 Refer to PIC 11. Locate provided threaded rod. Align and fasten it to the top mounting hole of the light assembly.
- **STEP 10** Refer to PIC 12. Align the taillight assembly with the opening in the rear fender. Connect the wire harnesses to the new taillight.
- **STEP 11** Refer to PIC 12 and 13. Align the gasket over the opening in the rear fender. Align the taillight assembly over the opening and slide the clip located on the bottom backside of the light over the rear fender. Align the threaded rod on the backside of the taillight with the mounting hole on the tab of the rear fender.
- **STEP 12** Locate provided lock nut. From the inside of the rear fender place the lock nut onto the threaded rod protruding from the backside of the rear fender tab. Make adjustments to the light before fully tightening the lock nut.
- **STEP 13** Make adjustments to the gasket and taillights position as needed. Fully tighten all hardware. Turn motorcycle on and test the light for proper operations before riding.

HD PART 73381-12 INSTALLATION

- **STEP 14** Refer to PIC 14. Locate provided backer plate. Align it with the gasket, but do not attach it to the rear fender. Pull the rear light's wiring harnesses through the openings in the plate.
- **STEP 15** Refer to PIC 15. Locate OEM circuit board that was removed in Step 5. Connect rear lighting harness to the circuit board. Secure all wires in a safe place. Ensure that wires are secured away from any moving parts, excessive heat or pinch points.
- **STEP 16** Refer to PIC 16. Locate provided taillight and two (2) provided socket head cap screws. Align the circuit board and backer plate with the taillight, and secure them all together using the provided screws. Fully tighten hardware.
- **STEP 17** Refer to PIC 17 and 18. Align the gasket over the opening in the rear fender. Align the taillight assembly over the opening and slide the clip located on the bottom backside of the light over the rear fender. Adjust placement of the gasket behind the light.
- **STEP 18** Locate provided flat washer and hex head bolt. Place the washer onto the bolt. From the inside of the rear fender insert the bolt and washer assembly through the aligned mounting holes of the tab on the rear fender and the taillight assembly.
- **STEP 19** Make adjustments to the gasket and taillight's position as needed. Fully tighten all hardware. Turn motorcycle on and test the light for proper operations before riding.
- **STEP 20** Turn motorcycle on and test the light for proper operations before riding.
- **STEP 21** Reinstall license plate backer and license plate, if applicable.

SECURE ALL WIRING AWAY FROM ANY MOVING PARTS, PINCH POINTS OR EXTREME HEAT. KURYAKYN WILL NOT ISSUE A WARRANTY ON ANY ELECTRICAL COMPONENT THAT FAILS DUE TO PINCHED, CRIMPED, BROKEN, ABRADED, MELTED OR FRAYED WIRES.
