THROTTLE SIDE PROCEDURE


- **STEP 1** Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.
- ▲ WARNING A FACTORY SERVICE MANUAL WILL BE HELPFUL IN PERFORMING THIS INSTALLATION. DO NOT ATTEMPT TO PERFORM THIS INSTALLATION IF YOU ARE NOT CONFIDENT IN YOUR ABILITY TO COMPLETE ALL OF THE STEPS IN THE PROCEDURE; CONSULT A TRAINED TECHNICIAN. IMPROPER INSTALLATION COULD RESULT IN SERIOUS INJURY OR DEATH.

STEP 2 Separate the switch housing by removing the hardware located on the top and bottom of it. Set hardware aside, it will be reused.

Note: You may also have to loosen the master cylinder clamp to allow the switch housing halves to separate.

- **STEP 3** With the switch housings separated, slide the stock handgrip assembly off the handlebars. It will not be reused.
- **STEP 4** Refer to FIG 1. Slide on the new grip assembly in the desired orientation making sure the teeth on the inside of the grip assembly are positively engaged in the teeth of the sensor, and the flange is seated inside the switch housing.
- **STEP 5** Reassemble the switch housings using the hardware that was removed in STEP 2. Tighten the screws on the master cylinder clamp if they were loosened.


CLUTCH SIDE PROCEDURE

NOTE: Refer to your service manual for additional information on the following Steps.

STEP 6 Separate the switch housing by removing the hardware located on the top and bottom of it. Set hardware aside, it will be reused.

Note: You may also have to loosen the clutch control clamp to allow the switch housing halves to separate.

- **STEP 7** Remove the clutch side grip. A sharp knife may be used to cut the grip lengthwise allowing you to "peel" the stock grip from the handlebar.
- **STEP 8** Sand the clutch side handlebar surface with 80-100 grit sandpaper or emery cloth to remove any previous glue or rubber residue. This provides a pristine metal surface for the new grip.
- **STEP 9** With an ammonia based cleaner or similar degreasing agent and a clean rag, wipe off the exposed handlebar.
- **STEP 10** Refer to FIG 2 and 3. With the wider side of the grip's flange positioned on the bottom, slide the grip onto the handlebar.
- **STEP 11** Reassemble the switch housing halves and secure them with the screws removed in Step 6. Tighten the clutch control clamp if it was loosened in Step 6.
