STEP 1


Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.



STEP 2 Refer to PIC 2 and 3. Open the saddlebag and remove the side cover. Set covers aside, they will be reused.



STEP 3 Refer to PIC 4 and 5. Remove pillion step holder cover by removing one (1) flange bolt from the top front corner, one (1) screw from the bottom front corner (below the step), and two (2) trim clips from the top and bottom rear side. Apply a small amount of blue Loctite to the threads of the bolts that were removed. Set all aside, they will be reused.

- STEP 4 Refer to PIC 6 and 7. Unfasten and remove the screw and washer assembly securing the pillion step pin in place. Apply a small amount of blue Loctite to the threads of the screw that was removed. Remove the existing pillion step pin from the pillion step holder. Carefully remove the pillion step from the holder, be careful not to lose the pillion step clip plate, steel ball and adjust click spring. Set all hardware aside, they will all be reused.
- STEP 5 Refer to PIC 8 and 9. Locate provided passenger floorboard and the following OEM parts: pillion step click spring, steel ball, and the pillion step click plate.
- STEP 6 On the front side of the adapter of the provided floorboard, insert the spring into the top hole, followed by the steel ball and click plate. When the floorboard is aligned with the motorcycle the flat edge of the click plate should facing towards the bike, and the steel ball should be covered by the bottom small hole of the plate.
- STEP 7 Locate OEM pillion step pin, flat washer, and the screw that were removed in Step 4. Lightly grease the pillion step pin.
- STEP 8 Align and place the floorboard with the pillion step holder. Be sure the click plate flat edge is still in the correct position of holding the steel ball, and the flat edge is aligned under the top edge of the pillion step holder.
- STEP 9 Refer to PIC 10. Align the mounting holes of the adapter of the floorboard and pillion step holder. Insert the pillion pin from the rear of the holder, pushing it towards the front of the motorcycle. Test fold the step up and down to assure the pillion click plate is properly intact and the floorboard functions accordingly. The floorboard should stay in place when folded up.
- **STEP 10** Refer to PIC 10. Secure pillion step pin in place by reinstalling the flat washer and screw that were removed in Step 4.

TORQUE VALUE FOR PILLION STEP PIN SET SCREW: 3.1 FT-LB (4.2NM)

- **STEP 11** Reinstall the pillion step holder cover using the hardware that was removed in Step 3.
- **STEP 12** Reinstall the side cover that was removed in Step 2.
- **STEP 13** Repeat Steps 2 through 12 on the opposite side for the remaining passenger floorboard.
