STEP 1

Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.

STEP 2

IF INSTALLING WITH KURYAKYN PN-7098 QUICK RELEASE ATTACHMENT POINT KIT (sold separately), continue to Step 6.

IF INSTALLING WITH H-D 4-POINT DOCKING HARDWARE, continue to Step 3.

STEP 3


Refer to PIC 2 and 3. Remove the docking point fastener and docking point from the front of the mounting plate. Set it aside.

STEP 4

Refer to PIC 4 and 5. Locate provided one (1) flat washer. Place washer onto the front docking point arm. Reinstall the docking point and fastener that was removed in Step 3. Fully tighten hardware.

STEP 5

Repeat Steps 3 through 4 on the opposite side.

STEP 6 Refer to PIC 6. Starting on the right (brake) side. Locate provided right bracket. Align the front mounting hook with the front connecting point of the attachment point kit.

STEP 7 Refer to PIC 7. With the rear fastening latch pulled back, slide the rear mounting latch over the rear connecting point of the attachment point

STEP 8 Refer to PIC 8. Release the locking latch to secure the quick release mount in place.

STEP 9 Refer to PIC 9. Repeat Steps 6 through 8 for the left (clutch) side.

STEP 10 Locate Multi-Purpose Backrest (P/N 1660 or 1661 - sold separately). Test fit the backrest between the fixed mounts. The Backrest should slide easily between the fixed mounts.

STEP 11 Refer to PIC 10 through 12. Install the backrest to the Fixed Mounts by inserting one of the supplied (with the backrest) 5/16"-18 X 7/8" countersunk socket head cap screws through one of the supplied shoulder washers, through the Fixed Mount and threading it to the Driver/Passenger Backrest on each side. Fully tighten hardware. If these fasteners are loosened or removed, see WARNING! below.

> TORQUE VALUE FOR BACKREST SCREWS: 15 FT-LBS (20.34 NM)



BOTH PIVOT/HINGE SCREWS MUST HAVE THREADLOCK COMPOUND RE-APPLIED AND RE-TORQUED ONCE REMOVED, AFTER INITIAL INSTALLATION. FAILURE TO DO SO MAY RESULT IN UNINTENDED LOOSENING AND MAY CAUSE SERIOUS INJURY OR DEATH. THE FEMALE THREADS IN THE MULTI-PURPOSE BACKREST AND THE THREADS ON THE REMOVED SCREWS WILL NEED TO BE CLEANED TO REMOVE ANY THREADLOCK RESIDUE BEFORE RE-INSERTING. RE-APPLY LOCTITE® THREADLOCK BLUE 242® OR EQUIVALENT, AS SHOWN IN PIC 10, RE-TORQUING TO 15 FT-LBS (20.3 NM) USING A TORQUE WRENCH AND 3/16" ALLEN/HEX KEY ATTACHMENT. LET CURE PER THE THREADLOCK MANUFACTURERS INSTRUCTIONS AFTER INSTALLATION. IF YOU DO NOT WISH TO APPLY THREADLOCK, THEN ORDER A NEW SERVICE KIT, (P/N 991660) WHICH WILL CONTAIN SCREWS WITH BLUE THREADLOCK ADHESIVE PRE-APPLIED.

STEP 12

Refer to PIC 14 and 15. Check the operation of the Backrest by folding the locking levers to the straight out position. Lower or raise the backrest to the desired location. Fold the locking levers over to lock them in place. Gently rock the Backrest back and forth to ensure the locking pins are engaged in the notches in the Fixed Mounts. Repeat for the other position of the Backrest. Visually inspect the Shoulder Washers and Countersunk Socket Head Cap Screws at the pivot point for any signs of loosening before each ride. Kuryakyn requires checking all backrest attaching fasteners to the torque specifications defined in these instructions every 3,000 to 5,000 miles.

Note: See instructions for Multi-Purpose Driver/Passenger Backrest, P/N 1660 or P/N 1661, for adjustment procedures.
